RoHS – Declaration of Conformity

The RoHS Directive (Restriction of certain hazardous substances) 2011/65/EU restricts the use of certain hazardous substances in electrical and electronic equipment. This restricts the use of lead (Pb), among other materials. To give you greater overview of the contents of the RoHS Directive, the following table shows the individual substance groups.

Devices placed on the market after 01.07.2006 must not exceed the following limits of certain materials:
